AMENDMENT TO CONSENT ORDER

It is hereby agreed between the Department of Business Regulation (“Department”) and The Beacon Mutual Insurance Company (“Respondent”) as follows:

WHEREAS, the Department and Respondent entered into a Consent Order dated July 27, 2007 (the “Consent Order”);

WHEREAS, the Department and Respondent have agreed that it is not possible for Respondent to calculate the amount due to be distributed to Certain Eligible Policyholders pursuant to Paragraph 4 of the Consent Order without the validation of all shared earnings due from Beacon to certain Eligible Policyholders as of March 31, 2008; and

WHEREAS, the Department and Respondent have agreed to amend the Consent Order to allow for the proper calculation of the distribution.

WHEREFORE, based upon the foregoing, Respondent and the Department have agreed as follows:


1. Respondent and the Department agree that the final date for payment of the distribution to Eligible Policyholders by Respondent pursuant to Paragraph 4 of the Consent Order shall be extended from March 31, 2008, to April 30, 2008.

2. Except as specifically modified by this Amended Consent Order, the remainder of the terms and conditions of the Consent Order shall remain in full force and effect.

Counsel for the Department and Respondent hereby consent and agree to the foregoing on behalf of their respective clients the 10th day of March, 2008.




